RESOLUTION DESIGNATING ANNUAL POLLING PLACE

RESOLUTION NO. 24 – 16

WHEREAS, it is important that citizens exercise their right to vote at their local polling place;

WHEREAS, Minn. Stat. §204B.16 requires the Town Board to designate its local polling place for elections annually;

WHEREAS, Livonia Township has 3 precincts and 2 polling places;

WHEREAS, Sherburne County Auditor manages the absentee/early voting for Livonia Township for Federal and State Elections;

WHEREAS, Livonia Township uses 1 polling place for the Annual Township Election;

WHEREAS, Livonia Township manages absentee voting for the Annual Township Election.

NOW, THEREFORE, BE IT RESOLVED, that as required by Minn. Stat. §204B.45, the Town Board of Livonia Township, Sherburne County, Minnesota does hereby designate Zimmerman Livonia Fire Station One Event Center, located at 26140 136th St NW, Zimmerman, MN 55398, Livonia Township, Sherburne County, Minnesota as the polling place for state and federal elections for Precinct 1 and Precinct 3 in 2025; and

NOW, THEREFORE, BE IT RESOLVED, that as required by Minn. Stat. §204B.45, the Town Board of Livonia Township, Sherburne County, Minnesota does hereby designate the Livonia Town Hall, located at 11162 265th Ave NW, Zimmerman, MN 55398, Livonia Township, Sherburne County, Minnesota as the polling place for state and federal elections for Precinct 2 in 2025; and

NOW, THEREFORE, BE IT RESOLVED, that as required by Minn. Stat §204B.45, the Town Board of Livonia Township, Sherburne County, Minnesota does hereby designate the office of Sherburne County Auditor/Treasurer, located at 13880 Business Center Drive, Elk River, Minnesota in Sherburne County as the polling place for absentee/early voting for state and federal elections in 2025;

AND FURTHER BE IT RESOLVED, that the Town Board of Livonia Township, Sherburne County, Minnesota does hereby designate the Town Hall at 11162 265th Ave, Zimmerman, MN, Sherburne County as its polling place for township elections and absentee voting for township elections in 2025; and

BE IT FINALLY RESOLVED, that the township notify residents of this designation by following the requirements of Minn. Stat. §205.16.
