

LIVONIA TOWNSHIP REGULAR BOARD MEETING MINUTES HELD AT THE LIVONIA TOWNSHIP HALL

February 22, 2016

Supervisors present: Doebler, Hass, Hewitt, Manthei and Pool.

Staff present: Clerk/Treasurer Hammre, Deputy Clerk/Treasurer Fiedler, Maintenance Coordinator Berghuis

Chairman Hewitt called the meeting to order at 7:00 pm.

- 1.1 Pledge of Allegiance: The assembly recited the Pledge of Allegiance.
- 1.2 Approve Regular Meeting Agenda: Manthei/Doebler unanimous to approve the Regular Meeting Agenda.
- **1.3 Approve Consent Agenda:** Hass/Pool unanimous to approve Consent Agenda as follows: **Item A)** January 25, 2016 Regular Board Minutes; **Item B)** February 8, 2016 Special Meeting Minutes; **Item C)** February 8, 2016 Workshop Meeting Minutes.
- **1.4 Sheriff Report**: Sergeant Wilson reported there were 176 calls for service in January: 72 of the calls were for traffic stops, the remainder of the calls were for various reasons. Sergeant Wilson recommended that ice fish houses should be removed from lakes due to the risk of refreezing to the lake surface with standing water from rain and melting as well as deteriorating ice conditions. Sergeant Wilson also cautioned residents about several scams targeting residents including Payday Loan scams and Skype extortion.

- **1.6 Engineering Updates: Bogart Contractor Insurance Requirements)** Discussion about insurance coverages required of contractors to ensure that the Township is protected, more research to be done to ensure that the Township is protected in the future as liability caps are increased; **112**th **St Phase 2**) Bid deadline is March 1st, the winning bid will go for approval before the Sherburne County Board of Commissioners on March 15; **Engineering Standards**) Home building is increasing in the Township, a workshop was suggested to update the current standards. Discussion about the Endangered Species, the Northern Long Eared Bat, that can be negatively impacted by tree removal after April 1st and the necessity of moving up the tree removal on 112th St Phase 2 area before that time. Grubbing will be done later to prevent erosion and additional erosion control costs.
- **1.7 Road Report:** Maintenance Coordinator Berghuis Researching snowplows for replacement of the oldest plow in 2017, several outdoor lights need replacing looking into options, Baldwin Township will store several pieces of equipment here to make room for their Annual Meeting.
- **1.8 Planning Commission Report Spencer:** The PAC met February 18, 2016 and recommended the following item for approval by the County Board of Commissioners: Request for CUP to erect a 50 foot amateur radio antenna support tower Livonia Township. The request to amend the Sherburne County Zoning Ordinance as it pertains to solar farms was tabled to the March 20116 PAC meeting. The public hearing was not closed.

Hass suggested a road workshop to research and discuss the various options to improve the safety of the Lake Fremont minimum maintenance road. Meeting set for April 4, 2016 at 7:00 pm, Livonia Town Hall.

- **3.0 OPEN FORUM** Lynda Bouley present to request the use of the trails at Sugarbush Park for a youth race as part of a local three race series for youth through Community Education, modeled after similar race series held in Elk River and Princeton. Livonia Town Board supportive of the event. Suggested that Bouley attend the next Livonia Park Board meeting. Hass/Hewitt unanimous to approve request.
- **4.1 Clerk Treasurers Report:** Hammre reported items of interest during the past month include: Sherburne County Parks, Trails and Healthy Living Meeting was held on January 28 where the importance of community coordination to prevent the duplication of amenities was discussed; Signature cards need to be updated.
- **4.2** Approve payment of claims and transfer funds: Hewitt/Doebler unanimous to approve payment of claims, including payroll, as submitted and to transfer \$44,000.00 from savings to checking to cover claim numbers 7549 –7579, check numbers 17146-17187 and Electronic Fund Transfers (EFT) #149-151 (February) Federal, State & PERA withholding tax.
- **4.3 Supervisor Reports**: Pool attended the Rinke Noonan Seminar with Supervisor Hass. Doebler attended the Grams Park Open House, commented on the concept plan and the good turnout for the event. **Hass** no report. **Manthei** discussed the sound system not working properly based on audience feedback, previous Supervisor recognition and the need to have a system to make sure issues are followed through. **Hewitt** the 3rd Annual Sugarbush Luminary Event had about 40 participants despite the cold temperatures. Discussion about possible Grant funding for park projects in the newly acquired addition to Sugarbush Park and the need for trail crossing signage when the trail crosses 239th Ave.
